Applications in the prescribed format are invited for filling up One post of Private Secretary (Group 'B' Gazetted Ministerial) and One post of Junior Translator (Group 'B' Non-Gazetted Non-Ministerial) in the Regional Office of the Ministry of Environment, Forest & Climate Change, Shillong from amongst officials of Central /State Government Departments/ Union Territories/ Public Sector Undertakings or Recognized Research Institutions or Universities or Statutory or Autonomous Organizations on deputation basis. The eligibility criteria required for the posts can be seen at **Annexure-I**.

The terms and conditions of the candidates selected for appointment on deputation will be governed as per the conditions laid down in Government of India, Department of Personnel & Training O.M. No. 6/8/2009-Estt dated 17.6.2010 as amended from time to time.

The period of deputation will be initially for three years and is likely to be extended further as per the guidelines of DoPT. The Period of deputation including period of deputation in another ex- cadre post held immediately preceding this appointment in the same office or some other office/ Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date prescribed for receipt of applications.
