Initial discussion:

Criteria for allowing import of used oil under Basel No. A3020:

The Matter was discussed in 115th Meeting of Expert Committee (EC) held on 4th August, 2022 and EC deliberated on the criteria/modalities for allowing import permission of used oil (Waste mineral oils unfit for their originally intended use). The CPCB representative informed that CPCB have already developed standard operating procedure (SOP) for used oil sector. The EC after discussing the issue was of the opinion that CPCB may forward copy of SOP and other relevant document to the chairman and member of EC so that the EC will discuss the issue in next meeting and finalized the criteria/modalities for allowing import of used oil. CPCB has now submitted the guidelines where guidance has been given for recycling of used oil and waste oil.

AGENDA NO. 1. IMPORT OF LEAD SCRAP (B1020/A1160)

1.1 Inclusion of ISRI Code: RINK in previous permission granted to M/s Jain Resource Recycling Pvt Ltd, M/s Ardee Industries Pvt Ltd., M/s Pilot Industries Pvt. Ltd and M/s Gravita India Ltd (for their Chittoor and Jaipur Plant)

These applicants have requested to add ISRI Code: RINK in their previous permission letter as the availability of "Rains" is very low due to export restrictions of many countries. Most of the countries prefer to export Whole Intact Lead Acid Batteries under ISRI code "Rink".

1.2 M/s Axora Resources Ltd, Chittoor, Andhra Pradesh

The application pertains to import of 20,000 MT of Lead Scrap (ISRI Code: Rakes, Racks, Ropes, Radio, Rails, Rents, Relay& Rains) (B1020/A1160). The matter was last discussed in 107th Meeting of EC and the recommendation of the EC is as follows:

"The committee observed that the production figure submitted by the applicant also included ingots remelted and not from the waste only. Based on these and the details submitted by applicant related to pollution control devices installed in the unit, the EC recommended import of 3,860 MT of Lead Scrap (ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay) (B1020). However, since the site visit has not been done by CPCB yet, the import permission will be granted only after the receipt of site visit report by CPCB stating unit is complying with SOP and without referring back to the EC. If the unit is not complying with SOP, then the application shall again be referred back to the EC. The EC also recommended that CPCB may verify that the Automatic Battery Breaking has been installed and working in the unit. After

receipt of CPCB inspection report, the application may be referred back to the EC for the inclusion of ISRI Code: RAINS (A1160) in the permission letter.”

CPCB visited the unit on 24th March, 2022 and submitted the report on 3rd August, 2022 stating that the unit is complying with SOP. The applicant then vide letter dated 24th August, 2022 has requested to issue permission letter for import of Lead Scrap including RAINS (A1160).

However, as per the recommendation of EC, the application may be referred back to the EC for the inclusion of ISRI Code: RAINS (A1160) in the permission letter.

1.3. M/s Geon International, Baddi, Himachal Pradesh

The application pertains to import of 6,000 MT Lead scrap /Batteries Scrap (ISRI Code: Radio/Rakes/Ropes/Relay/Rents/Racks/Rails/Rains) (B1020/ A1160). The matter was last discussed in 113th Meeting of EC and the recommendation of EC is as follows:

"The EC deliberated upon the proposal and noted that CTO under the Air and Water was expired in March, 2020. Further applicant has not submitted the recent data w.r.t. production, export quantity (if any), electricity consumption, GST paid etc. Accordingly, EC recommended to defer the proposal till the aforesaid details along with copy of valid CTO submitted by the applicant, matter would be taken up in next EC again"

The applicant vide email dated 30th August, 2022 has submitted the details as under:
