Then, the CPCB submitted the inspection report which is not complying with SOP and suggested some improvements. The applicant has now submitted the evidence of the improvements done by them.

The matter was last discussed in the 101st Meeting of EC and the EC recommended import of total 17,950 MT of used rubber tyres scrap/tube scrap for manufacturing of crumb rubber. The 50% of the quantity recommended above may be granted after submission of site visit report by CPCB stating compliance of SOP without referring the application to the EC. The applicant has now informed that CPCB has visited their unit on 27/01/2022 and requested to release the balance quantity & also consider the new application for FY 2021-22. However, CPCB has not submitted the inspection report to the ministry yet.
