The matter was last discussed in 136<sup>th</sup> meeting of EC and the EC after deliberation on the proposal recommended that export of 200 MT of Cadmium Scrap for recycling/recovery purpose will only be allowed subject to submission of Valid Authorization under the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 in the name of the applicant i.e. M/s Chennai Recycling Services, Mogappair East, Chennai.

Now, the applicant *vide* email dated 27/11/2024 has mentioned that they approached the Tamilnadu State Pollution Control Board and noted that transporters/logistics service providers/shippers have no separate authorisation given, but they can be included in the generator's authorisation.
