#### Sir/Madam

I am directed to say that you have qualified for Medical Examination (Part-I&II) and walking test on the basis of the result of the Indian Forest Service Examination 2024 declared by Union Public Service Commission. Accordingly, you are required to undergo Medical Examination Test as per schedule attached and instruction given below. Please note that you must carry original Admit Card for Medical Examination (Part-I&II).

#### 1. Medical Examination:-

- i. The physical standards prescribed for appointment to the Indian Forest Service (IFS), vide Rule 18 of the IFS (Examination) Rules, 2024 are laid down in Appendix III available on the website http://www.ifs.nic.in and may please be carefully studied.
- ii. The medical Examination will be conducted On 22-09-2025 at 8:45 sharp at Medical Board Department, Lady Hardinge, Hospital, New Delhi (No candidate shall be entertained after 09:00 AM) by a duly constituted "Central Standing Medical Board" in the hospital.

Allocation of candidate to the Medical test along with date of medical has been indicated in the Annexure-I, respectively to this letter and no change whatsoever, will be allowed in this matter in any circumstances.

- iii. On the subject of medical examination, particular attention of the candidates is invited to the following:
- a. No fee is required to be paid by them for Medical Examination.
- b. The candidates are required to take with them 10 passport size recent (not more than 15 days) colour photographs with white background, with name and date printed at below, while reporting for Medical Examination. Edited Photographs will not be allowed.
- c. Candidates wearing glasses are required to carry a recent certificate indicating the power of the glasses alongwith the glasses. Prescription slip should indicate name & age of the candidate.
- d. Candidates are requested to come fasting for 8-10 hours on the day of the medical examination.
- e. Candidates with doubtful colour vision are entitled to two sets of tests- by

Ishihara's Plates and Edridge Green Lantern. While fulfilment of requirement by either of the Tests is considered sufficient, later appeals from candidates that they are adjudged UNFIT on test by only one of the tests without allowing them the opportunity of being tested by the other, will not be considered. Such Examination should be insisted upon and in case of the request not being agreed to by the following days of the Medical Examination.

- f. Candidates are required to bring all document(s) pertaining to treatment, if any:
- g. Presence of candidates may be required till 6:00 PM and for a further period of few days in case, investigation/hospitalization is considered necessary for which candidates are required to come prepared.

### 2. Address Change & Miscellaneous Correspondence:-

The candidates should intimate promptly to this Ministry, all change(s) in their mailing address, if other than mentioned by the in UPSC. All correspondence should be address only to the following:

Request for postponement of the Medical Examination will not be entertained except under exceptional circumstances, which should be supported, by necessary reasoning/proof.
