The applicant has requested for the extension of validity period of Permission for Import of Lead Scrap (Basel No. B1020) granted under F.No.23/40/2024-HSM, Dated 16th May, 2024 for the import of quantity 1,483 MT. It is mentioned by applicant that DGFT certificate was issued on 1st November 2024, which was delayed by seven months, further affecting our ability to complete the import process within the given timeframe.

1.11. M/s 3S Global Greens Pvt Ltd, Dewas, Madhya Pradesh (F.No.23/124/2021-HSM)

The applicant has requested an extension of the validity period of the permission granted for the import of various Lead Scrap (ISRI codes: Rains, Rono, Roper, Radio, Racks, Ropes, Rails, Rents, Rakes, Relay, Roses, Reels, Lead Grids, Lead Paste, Lead Dross, Lead Scrap in crushed or powder form, Lead Acid Accumulators, Lead Powders & Flakes, and Rink) vide letters dated 09.08.2024, 04.02.2025 & 29.10.2025. It is stated by applicant that, against the total approved quantity of 1,282 MT, only 200 MT has been imported so far. Further, 500 MT is expected to arrive by mid-February 2026, while the remaining quantity is likely to arrive by the end of January 2026.

1.12. Chloride Metals Limited, Kolar, Karnatka (F.No. 23-153-2014-HSMD)

The applicant has submitted a request vide letter dated 18.11.2025 seeking clarification regarding non-applicability of Prior Informed Consent (PIC) for import of Wet Lead Acid Battery scrap (ISRI Code: RINKS) from Malaysia. The request pertains to one consignment already arrived at Chennai Port, which has been withheld by Customs for want of PIC. The applicant has referred to the clarification issued in the 138th EC meeting held on 24.10.2024, wherein it was decided that PIC is not required for imports from countries, which do not follow the Basel Convention and/or where no established mechanism exists for issuance of PIC, and permissions were amended accordingly in similar cases. The matter is placed before the Committee for examination and appropriate decision.
