AGENDA NO. 1. IMPORT OF LEAD SCRAP/BATTERIES SCRAP (B1020/A1160)

1.1. Request for removal of condition i.e. "Prior Informed Consent from the Exporting Countries Required" by M/s Eswari Global Metal Industries Pvt Ltd, Karnataka, Pilot Industries, Alwar and Ardee Industries, Andhra Pradesh - reg.

M/s Eswari Global Metal Industries Pvt Ltd, Karnataka, Pilot Industries, Alwar and Ardee Industries, Andhra Pradesh has requested to reconsider the condition for Basel no. that fall under Part 'A' of Schedule III in the Hazardous and Other Wastes (Management and Transboundary Movement) (HOWM) Rules, 2016 as amended from time to time which mandates the Prior Informed Consent (PIC) from exporting country for import of hazardous waste. However, as per the Basel convention procedures prior inform consent from the importing country is required.

It is mentioned that the purpose of Basel convention is to ensure that the hazardous waste is recycled in an environmental sound recycling facility and the importing country is aware of the import of the waste. Since, MoEFCC has given permission only to environmentally sound recycling facility and without MoEFCC permission copy people cannot import hazardous wastes. They further stated that the permission of MOEFCC for imports might be considered as a Prior Informed Consent from the importing country. Hence, it will avoid any redundancy.

The matter was last discussed in 136th EC and the committee noted that this is a provision in the rules and this has been in force for many years. The applicant pointed out that the exporters find it difficult to provide this as there is no provision in the rules of the exporting countries and authorities there do not respond easily to them. Since the proposal involves an amendment to the rules, the committee after deliberation upon the proposal and hearing the views of applicants, recommended that the applicants may be asked to provide documentary evidence regarding the difficulties faced by them in the form of letter/email or any means of communication received from the exporters and authorities of the exporting country, efforts made by them, situation wrt some countries, etc. for further deliberation.

Now, the applicants have submitted the details. Accordingly, the matter is placed before the EC for deliberation/decision.
