

NOTIFICATION

No. A-12012/4/2005.P.II (.). The President of India is pleased to appoint Shri N. Thyagarajan, (CSL No.9185) a Section Officer of Ministry of Rural Development, to Grade-I (Under Secretary) of CSS purely on ad-hoc basis in Pay Band-III (Rs. 15600- 39100) with Grade Pay of Rs. 6600/- in the Ministry of Environment, Forest and Climate Change with effect from the forenoon of 18.07.2016 for a period upto 31.06.2017 or till the post is filled up on regular basis or until further orders, whichever is the earliest, in pursuance of the Department of Personnel and Training's Order No. 5/7/2016-CS.I (U) dated 14<sup>th</sup> July, 2016.

2. The ad-hoc promotion is subject to the following conditions:

- (i) The ad-hoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointment or to claim seniority in the Grade-I of CSS;
- (ii) The ad-hoc appointment may be terminated at any point of time without giving any reason there for;
- (iii) The service rendered on ad-hoc basis in the Under Secretary grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade;
- (iv) In case the officer has not undergone mandatory Level 'D' Training as enjoined in Cadre Training Plan for CSS, he will have to undergo the aforesaid training as per nominations made by the Department of Personnel & Training.
