



Functions of FC Division

- 1. To receive online application for forest clearance above 40 ha under FC Act 1980 from State Government and accord Forest Clearance (FC) on the recommendation of Forest Advisory Committee (FAC) and approval of Hon'ble Minister of Environment, Forest and Climate Change.
- 2. Forest Conservation Policies: Formulation and Implementation
- 3. Formulation and implementation of Forest Conservation Rules

Forest (Conservation) Act 1980

It was enacted on 25 October 1980

This has four sections, the important provisions are:

Section 2. Restriction on the de-reservation of forests or use of forest land.

Forest Clearance is given under this rule by MoEF & CC

Section 3. Constitution of Advisory Committee (FAC).

The Central Government may constitute a Forest Advisory Committee to advise that Government with regard to-

(i) the grant of approval. under Section 2; and

(ii) any other matter connected with the conservation of forests which may be referred to them by the Central Government.

3A. Penalty for contravention of the provisions of the Act.

Whoever contravenes or abets the contravention of any of the provisions of **Section 2**, shall be punishable with simple imprisonment for a period which may extend to fifteen days.

3B. Offences by the Authorities and Government Departments.

Where any offence under this Act has been committed -

(a) by any department of Government, the head of the department; or

(b) by any authority, every person who, at the time the offence was committed, was directly in charge of, and was responsible to, the authority for the conduct of the business of the authority as well as the authority;


shall be deemed to be guilty of the offence and shall be liable to be proceeded against and punished accordingly.

Section 4. Power to make rules.

Every rule made under this Act shall be laid, before each House of Parliament for approval.

- c) Forest (Conservation) Amendment Rules, 2014
- d) Forest (Conservation) Second Amendment Rules, 2014

Decentralisation

- Constitution of Regional Empowered Committee (REC) at each Regional Office to finally dispose of proposals involving upto 40 hectares of forest land (except mining, encroachment and HEPs) and all proposals related to linear projects
- General approval for construction and widening of two lane roads by the within 100 kilometres aerial distance from LAC
- General approval for creation of border security related infrastructure within five kilometers aerial distance from the International Border
- General approval for construction of two lane roads within 117 LWE affected districts irrespective of area of forest land involved
- Delegation of powers to competent authority in the State Govt. to issue permission for tree felling and commencement of work on linear projects without waiting for final FC once compensatory levies and land for CA is received
- Extension of general approval for diversion of forest land upto 5.00 hectares in each case for 14 categories of public utility projects by Government Departments in 117 LWE affected Districts till 31.12. 2018

- Finalization of FC for iron ore mines in Jharkhand and Odisha pending due to study of ICFRE and NEERI
- Strengthening of Regional Office and FC Division
