**OFFICE ORDER**

In terms of Govt. of India Notification No. 1/21/7/2019-Cab dated 14.06.2019 regarding amendment to the Govt. of India (Allocation of Business) Rules, 1961, Ministry of Jal Shakti has been created by insertion of new Article 19(A) in the First Schedule of Allocation of Business Rules, 1961 and following works of this Ministry have been transferred to Ministry of Jal Shakti:
