- (ii) The ad-hoc promotion shall not bestow on the incumbent any claim for regular promotion to the grade.
- (iii) The service rendered on ad-hoc basis in the grade would not count for the purpose of seniority in that grade for promotion to the next higher grade.
- (iv) The adhoc promotion shall not confer any right on the incumbents to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
