



  - The ad-hoc appointments may be terminated at any point of time without giving any reason thereof.
  - The service rendered on ad-hoc basis in the Selection Grade (Deputy Secretary) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
  - The ad-hoc promotion will remain subject to the outcome of the SLP (C) No. 30621/2011 (**Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors**) and the SLP (C) No. 31288/2017 and any other court case in connected matter.
