

In compliance of the Hon'ble National Green Tribunal's order dated 24<sup>th</sup> January, 2018 (copy enclosed) in O.A. No. 13/2018 in the matter of Jan Sahyog Manch vs. Union of India & Others, this Ministry hereby directs all PVC pipe industries "to publish a caveat with each product of PVC pipes containing lead, which are going to be phased out, that it contains lead which is harmful to the health". Compliance to these directions may be ensured by 30<sup>th</sup> April, 2018 under intimation to this Ministry.
