



Properties which are under joint family include agriculture land, building, orchard (Mango, Jack fruit etc in 3-4 bigha) etc. the approximate value of which would be more than 5 crore. After division of the joint family, complete details will be submitted. Grain arrears of value Rs 4-5 lac is expected to be received from HUF this year.
