2. Under construction linked plan, jointly allotted to husband Dr. P.K.Anand, I.A.S. and self a 3 Bed room Flat to be ready by end of 2011 at Sector 1 A, Manesar, New Gurgaon by M/s DLF Home Developers Ltd. Jointly paid Rs. 34.10 lac against total amount of Rs. 45.78 lac. He withdrew Rs. 1.51 lac from PPF a/c, Rs. 5 lac from GPF a/c. I withdrew Rs. 0.44 lac from my PPF a/c. Rs. 14 lac was paid from sale proceeds of aforesaid properties. Balance paid from our joint savings, part Pay Commission Arrears and rental income.

3. Under construction linked plan, jointly allotted to daughter Aanchal Anand, husband Dr. P.K.Anand, I.A.S. and self, a 3 Bed room flat M-525 second floor and to daughter Arpita Anand and us flat M-526, both to be ready by 2012 at Sector 1 A, Manesar, New Gurgaon by M/s Orchid Infrastructure P Ltd. Jointly paid Rs. 25.61 lac each against total amount of Rs. 57.80 lac each. Towards these flats, paid Rs. 31 lac from our sale proceeds of aforesaid properties, Rs. 1 lac from a Bank of Maharashtra loan and balance from our joint savings, balance Pay Commission Arrears and rental income, besides Rs. 3.5 lac paid by Aanchal Anand from her salary savings.
