Subject: Sub-Committee on Framing Guidelines for Import of Animal Feed including Dried Distillers Grains Soluble (DDGS)

In accordance with the decision taken in the 135th meeting of Genetic Engineering Appraisal Committee (GEAC) held on 25.07.2018, a Sub-Committee is being constituted to recommend a procedure for Import of animal feed in India.

 - (ii) To recommend a uniform procedure for dealing with applications related to import of animal feed including DDGS in India, clearly identifying role of different agencies with regard to examination and approval of applications
 - (iii) To recommend a proforma / application form for import of animal feed including DDGS.
4. The Sub-Committee may co-opt any other members/ experts for undertaking the task assigned.
5. The Sub-Committee shall submit its report to the GEAC within six months from the date of issue of this notification.
