**Car Auction Notice**

The National Afforestation and Eco-Development Board, Ministry of Environment Forest and Climate Change on behalf of President of India, invites sealed tender quotation for condemnation of old vehicle No.DL-3C-BM-3655(Indigo Car, Model 2009, running distance more than 1,61,000 lakh KM.)

2. The interested parties to purchase the condemn vehicle may inspect the vehicle between 24<sup>th</sup> July to 31<sup>st</sup> July, 2019 in between 3:00 P.M to 4:00 P.M. The vehicle is parked near the main entrance gate of Pt. Deen Dayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi. Interested parties are requested to carry the valid photo I.D. Card for the smooth entry in the CGO Complex.
3. Since the Vehicle is more than 10 years old, the transfer of the R.C shall not be permitted as per the rule and the vehicle is to be condemned by the way of dismantling of the vehicle, reserved price of the vehicle is Rs. 22,000/- and only those bidders are permitted to take part in the bidding, who agrees to offer the price of Rs.22,000/- or more. The interested parties shall be allowed for bidding only after submitting the earnest money deposit of Rs.5,000/- alongwith the quotation in favor of PAO, Ministry of Environment Forest and Climate Change, New Delhi.
4. The disposal of the vehicle shall be done strictly as per the rule "**as is where is basis**" and the transportation cost for the condemned vehicle to take out of the CGO Complex shall be borne by the interested parties and no certificate of worthiness or quantity shall be provided by the office.

The Last date to furnish the sealed quotation along with the EMD money shall be 5<sup>th</sup> August, 2019 by 3:00 P.M and the quotation should reach in the office of "Assistant Commissioner, NAEB, 7<sup>th</sup> Floor, Pt. Deen Dayal Antyodaya Bhawan,CGO Complex, Lodhi Road, New Dellhi" by the stipulated date time in the enclosed proforma (Annexure-I) alongwith the EMD money.
