CIRCULAR

Sub: Filling up the post of Evaluation and Monitoring Officer in the pay scale of Rs.15600-39100 (PB-3) with grade pay of Rs.6600/- (pre-revised) Pay Level – 11 (as per 7 CPC) in the Central Zoo Authority on deputation (including short term contract) basis.

One post of Evaluation and Monitoring Officer in the pay scale of Rs. 15600-39100 with grade pay of Rs.6600/- (Pay Band - 3) (pay Level-11, as per 7 CPC) is to be filled up on deputation (including short term contract) basis in the Central Zoo Authority, an autonomous organization under the Ministry of Environment, Forest & Climate Change on usual terms & conditions for Foreign Service.

The officers possessing the following qualifications and experience with less than 56 years of age are eligible for the post:-

Officers of the Central Government or State Government or Union territories or Public Sector Undertakings or Statutory or Autonomous Organizations;

- (a) (i) holding analogous post on regular basis; or
- (ii) with five years' regular service in pay band -3: Rs. 15600-39100 plus grade pay of Rs. 5400/-; and
- (b) possessing the following educational qualifications and experience : -

Essential:

- (i) Master Degree in Zoology or Wildlife as a subject from a recognized University or Institute;
- (ii) having three years' experience in the field of zoo management or wildlife management in zoos funded by the Central Government or State Government or in private Zoo recognized by the Central Zoo Authority or in Zoo or Wildlife related organization recognized by the Central Government or State Government.

Desirable:

Ph.D Degree in Zoology or Wildlife from a recognized University.

Note: -

- 1. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of Central/State Government shall not ordinarily exceed four year.
- 2. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.
- The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.
- 4. The deputation rules, regulations and provisions as issued from time to time by DoPT shall be applicable.
- 5. Applications received after the last date and incomplete applications will not be considered.
