Recognised Diploma or Certificate course in translation from Hindi to English and vice-versa or two years experience of translation work from Hindi to English and vice-versa in in Central or State Government Office, including Government of India Undertakng.

NOTE – 1: Period of deputation (including Short-term contract), including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisations or department of the Central Government shall ordinarily not exceeding three years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.

**NOTE -2**: For the purpose of appointment on deputation (including short-term contract) basis, the service rendered on a regular basis by an Officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pat scale and where this benefit will extend only for the post(s) for which that grade pay or pay sales in the normal replacement grade without any upgradation.

- 2. The period of deputation will be initially for a period of **Three Years**. The maximum age limit for appointment on deputation shall not be exceeding 56 (Fifty Six) years as on the closing date of receipt of application.
