Applications in the prescribed format are invited for filling up the following posts at the Regional Office, Ministry of Environment Forest and Climate Change, Nagpur (Erstwhile Integrated Regional Office, MoEFCC, Nagpur), purely on deputation basis from among the officers/officials of the Central Government or State Government or Union Territories or Autonomous or Statutory Organization or Public Sector Undertakings or University or Recognized Research Institution. Qualifications required for the posts can be seen at **Annexure I to II** respectively.

The terms and condition of the conditions of candidates selected for appointment on deputation basis will be governed as laid down in the Government of India, Deptt. Of personnel & Training OM. No. 6-8/2009- Estt Dated 17.06.2010 &MoEF&CC File No.6-21/2010-ROHQ (Vo.LI) dated 19.08.2016 as amended form time to time.

The period of deputation will be initially for three years and likely to be extended up to 5 Years. The Period of deputation including the period of deputation in the ex-cadre post held immediately preceding this appointment in the same office or other office/department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment of deputation shall not be exceeding 56 (Fifty Six) Years as on the closing date prescribed for receipt of application.
