Terms and Conditions for Technical Associate (On contract basis through Service Provider)

The terms and conditions for engagement of Technical Associate is similar to the guidelines of DST. However some additional terms and conditions have been added. The terms and conditions for engagement of Technical Associate post is given as follows:-

- **1.** The engagement to the post of Technical Associate is **purely on contract basis for a period of one (01) year**. The Contract does not imply to Technical Associate for any assurance or guarantee for subsequent employment in Regional Office. Extension of period of engagement beyond the stipulated period shall vest with the Regional Office, Sub-Office, Shimla.
- **2. Emoluments:** They will be given a consolidated emolument of Rs 37,000/- + HRA (as applicable) as per OM No. DST/PCPM/Z-06/2022 dated June 26, 2023 of Department of Science & technology, Ministry of Science & Technology, Government of India, New Delhi.
- **3. House Rent Allowance (HRA):** RO will not provide any accommodation to the Technical Associate engaged on contract basis. House rent allowance will be allowed as per the Central Government rules. The basic for calculating HRA will be the actual stipend of the Technical Associate.
- **4. Medical Benefits:** They will be entitled for medical allowance as applicable in the RO for himself/herself only.
- **5. Leave and other entitlement benefits:** Technical Associate will be entitled for 2 days casual leave per month only on calendar year basis. A maximum of 10 days of Casual Leave will be allowed to be carried forward, from the balance as on 31st December, of one calendar year to the next calendar year.
 - 5.1 Casual Leave would not be normally granted for more than 5 days at one time, except under special circumstances. Also, CL will be granted only from leave due to the person.
 - 5.2 No advance leave will be permitted.
 - 5.3 Participation in any scientific event/workshops in India or abroad only in connection with work related to RO will be treated as "on duty".
 - 5.4 Maternity/Paternity leave as per Govt. of India instructions issued from time to time would be available to female candidates.
 - 5.5 There is no provision of compensatory leave for contractual employees.
- **6. Bonus & Leave Travel Concession:** They will not be entitled to these allowances.
- **7. Retirement Benefits:** They will not be entitled to these benefits.
- **8.** The engagement of Technical Associate is on full time basis. They are required to submit themselves to the discipline, regulation of the RO in which they are working.
- **9.** The Technical Associate DSS-GIS will be required to attend the office during the normal office hours (9.00 AM to 5.30 PM) of otherwise, in exigency of the work.

10. If required, Technical Associate DSS-GIS will have to go on tour. While on tour they will be entitled to T.A. & D.A. as per entitlement.

- **11.** Compensatory leave will be granted only for works of special nature, not the routine project work in which a particular TA is engaged.
- **12.** In case they are absent from the work beyond their entitled leave, proportionate deduction from their emoluments will be made.
- **13.** If the Technical Associate DSS-GIS (on Contract) wants to leave the contractual appointment, he or she will have to give at least one month's advance notice to Sub-Office, Shimla.
- **14.** Any kind of paid or honorary part-time or full time employment or private is not permissible during the tenure of contract.
- **15.** Technical Associate DSS-GIS will work under the supervision of Regional Officer, Sub-Office, Shimla
- **16.** Technical Associate DSS-GIS will have to submit a report of the work carried out by them every month to his/her supervisor apart from daily work progress.
- **17.** The performance and work progress of the Technical Associate DSS-GIS will be reviewed by the Committee constituted by the Regional Officer, Sub-Office, Shimla on completion of the six months.
- **18.** The Technical Associate DSS-GIS will observe all security measures followed in the Sub-Office campus. They will not bring any unauthorized person or material inside Sub-Office, campus; neither will they carry anything outside from Sub-Office campus.
- **19.** The Technical Associate DSS-GIS will not have any Intellectual Property Right for the work assigned to them under the project or otherwise.
- **20.** The contract will be terminated:
 - a) On the expiry of term of contract without notice.
 - b) In case the competent authority is not satisfied with his/her work and conduct, contract may be terminated at any time.
