GUIDELINE FOR IMPLEMENTATION OF SWACHHTA ACTION PLAN 2021-22

Background:

To accelerate the efforts to achieve universal sanitation coverage and to put focus on sanitation, the Prime Minister of India had launched the Swachh Bharat Mission on 2nd October 2014. The mission was implemented as nation-wide campaign/Jan andolan which aimed at eliminating open defecation in rural areas during the period 2014 to 2019 through mass scale behavior change, construction of household-owned and community-owned toilets and establishing mechanisms for monitoring toilet construction and usage. Department of Drinking Water and Sanitation, Ministry of Jal Shakti has been entrusted to build toilet and solid waste management facilities in rural areas and Ministry of Housing and Urban Affairs for urban areas.

Swachhta Action Plan (SAP) is an inter-Ministerial initiative of Government of India, it has been added as a sub-scheme under EEAT Scheme for the year 2021-26. SAP of this Ministry was initiated in the year 2017-18. A separate budget head was created for this scheme in the year 2017-18. Department of Drinking Water and Sanitation, Ministry of Jal Shakti is the nodal Ministry looking after SAP. Under SAP, Ministry carries out awareness programmes for general public/communities Single Use plastics and Air & Water Pollution through State/UT Nodal Agencies.

To oversee, execute and monitor the programmes under Swachhta Action Plan, the Swachh aur Swasth Bharat (SSB) Cell was established in the Ministry in the year 2017-18. The Ministry is providing funds to the State/UT Nodal agencies since 2018-19 to implement Swachhta Action Plan.

Mission

Since time immemorial India as a civilisation has learnt to co-exist with nature. We have been a civilisation wherein even rivers, trees, animals have been worshipped, taken care of, not only that our harmonious and symbiotic nature of living had been an example to follow for the world. Swachhta Action Plan is a step in that direction to rejuvenate the glorious past practices for a solution to modern problems. Our societies have played an important role in

teaching us to respect and nurture our environment. We have been taught to love, respect and take care of living as well as non-living things. The Swachh Bharat Movement launched by Hon'ble Prime Minister of India is one step forward in that direction only.

Swachhta Action Plan of this Ministry is helmed at making Swachhta a daily routine of people's life. The purpose is to bring convergence of contributions from individual, community, organization at one platform for bringing sustainable and visible change in the society by promoting use of toilets, garbage management, pollution free environment and better sanitation practices which will yield a neat and clean environment.

Aims & Objectives

SAP of the Ministry is aimed at raising awareness on following themes:-

- Awareness on curbing the Single Use Plastics (SUPs)
- Awareness on Air and Water Pollution

With above aim, a Swachhta Action Plan is formulated every year and shared with Department of Drinking Water and Sanitation, Ministry of Jal Shakti, the nodal Ministry for Swachh Bharat and circulated among State/UT Nodal Agencies. SAP of FY 2021-22 is given at **Annexure A.**

Administrative Set Up

SAP is implemented through Ministry designated State/UT nodal agencies (SNAs) across the country which were previously nominated by State/UT Governments for Environment Education Awareness Training Scheme. List of SNAs is enclosed at **Annexure B**.

Implementation Plan

The Swachhta Action Plan is implemented by State/UT Nodal Agencies. The action plan contains programmes on a defined theme which are key for comprehensive realization of Swachh Bharat.

States/UTs are required to prepare and submit their proposal in accordance with the SAP of the Ministry. They are free to choose the geographic location in their respective States/UTs based on their assessment and need of intervention related to that theme. As for example, around 100 cities in 22 States across the country falls under the category of non-attainment city with respect to **Air Pollution**. Under, Swachhta Action Plan, SNA may choose the hotspot city wherein there is a need to initiate mass awareness on air pollution.

In the current financial year special focus may be given to raise awareness on **harmful effects of Single Use Plastics** thereby encouraging citizens to curb its use. Furthermore during every programme under SAP mask and sanitiser should be distributed among the participants and underprivileged sections of the society.

Increasing the reach of awareness programmes

SAP programmes should include participants in the ratio of 70:30 i.e 70 % general public/local communities and 30 % students. For holistic execution of SAP it becomes essential that the awareness programme reaches as many people as possible. Further, SNA may involve:

- i. School/College Students
- ii. Volunteers of Eco Clubs
- iii. Street Vendors
- iv. NSS, Scouts & Guides volunteers
- v. Retired and serving Government Officers
- vi. Civil Defense volunteers
- vii. Members of Resident Welfare Association
- viii. Scientists, Research Scholars of Universities/ Academic Institutions
- ix. Non-Governmental Organizations (NGOs) / Trust / Registered societies/ Industries / hospitals / hotels etc.
- x. Members of Civil Society
- xi. General Public

While initiating any programme participants should take the Green pledge approved by the Ministry given as under:

Green Pledge

I shall do my best for protecting the Earth and its natural Environment.

I shall adopt such practices that minimize wastage.

I shall reuse whatever I can.

I shall take care to clean up the environment.

I shall reduce the waste we create.

I shall plant more trees.

I shall conserve energy and water.

I shall adopt Green Good Deeds.

Submission of Proposal and Budget

States/UTs are required to submit their proposal in accordance with Swachhta Action Plan 2021-22. As per the plan each State/UT will organize 12 programmes in a financial year under following themes:-

- 1. Awareness on curbing the Single Use Plastics (SUPs)
- 2. Awareness on Air and Water Pollution

Under each theme, total six programmes are to be organized. A suggested list of programmes are given in the Swachhta Action Plan 2021-22 which may be seen at **Annexure A**. Out of the suggested list "Swachhta Pakhwada" and "Swachhta Hi Seva" programmes are mandatory. States/UTs should submit their proposal in the prescribed format given at **Annexure C**. The budget of the Swachhta Action Plan has been kept at Rs 20 lakh (maximum) for each State/UT, this amount will be released in a single installment subject to due approval of competent authority.

Reporting

SAP of the Ministry is being monitored by Cabinet Secretariat. As per the advisory received from the DDWS, Ministry of Jal Shakti, the SAP reports are to be uploaded in the SAP website (https://swachhataactionplan.gov.in) with financial and physical progress. Accordingly, SNA shall submit their reports to the Ministry annually in the prescribed format given at Annexure **D**. Furthermore States/UTs are required to adhere the provisions of GFR 2017 in full letter and spirit.
