**Subject: Assistance to State Govt. of Manipur for the Annual Plan Operation (General Works) during 2022-23 for implementing during 2023-24 under the CSS: Forest Fire Prevention & Management – Release of 2<sup>nd</sup> installment.**

Sir,

In continuation of this Ministry's letter of even number dated 01.09.2022, I am directed to convey the approval of competent authority for sanction and release of **Rs. 106.61 lakhs (Rupees One hundred six Lakh and sixty one thousand only)** as the **release of 2<sup>nd</sup> installment** of Central Share of Approved Annual Plan Operation (General Works) 2022-23 for implementing during 2023-24 under Centrally Sponsored: Forest Fire Prevention & Management Scheme to the **State Government of Manipur**, subject to the condition that the State Government on 90%: 10% cost sharing basis as Central Share and State Share.


2. The expenditure incurred is adjustable to the Demand No. 28. (Ministry of Environment, Forest and Climate Change) under the following Heads during Financial Year 2023-24 (Plan):

4. **This release amount is subject to adherence of the terms and conditions mentioned in this Ministry's letter of even number dated 01.09.2022**


