1.4. M/s Madhya Pradesh Woolen Mills Private Limited, Dewas, M.P. (F.No.23-124/2021-HSMD)

The applicant *vide* email has requested for change of name from M/s Madhya Pradesh Woolen Mills Pvt Ltd to M/s 3S Global Greens Pvt. Ltd in the permission granted for import of 1,282 MT of Lead Scrap as per (ISRI Code: (Rono, Roper, Radio, Racks, Ropes, Rails, Rents, Rakes, Relay, Roses, Reels, Lead Grids, Lead paste, Lead Dross, Lead Scrap in crushed or powder form, Lead acid Accumulators, Lead powders & Lead Flakes (B1020/A1160), RAINS (A1160) with not more than 2% of liquid/ electrolyte by weight in a given lot/consignment/container) and RINK (A1160) *vide* letter dated 09th August, 2024 and dated 04th February, 2025.

2. It is further mentioned that their company name has been changed to 3S Global

Greens Pvt. Ltd and they have submitted document like Bank Statement, GST registration certificate, PAN, Udyam Registration Certificate, Certificate of Incorporation and revised Consolidated Consent & Authorization (CCA) in the name of 3S Global Greens Pvt. Ltd.

1.5. M/s Skylead, Raigad, Maharashtra (F.No.23/87/2022-HSMD)

The matter was discussed in 140th meeting of Expert committee held on 20th December, 2024 and based on the information and details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 14,816 MT Lead Scrap as per ISRI Code: Radio/Racks/Rakes/Ropes/Relay/Rents/Rails/Rono/Range (B1020/A1160). Further, The 50% of the above recommended quantity (i.e. 7,408 MT) may be granted now and the remaining 50% quantity (i.e. 7,408 MT) may be granted after submission of site visit report by CPCB stating compliance of SOP without referring the application to the EC.

2. Thereafter, permission for 50% quantity was issued *vide* letter dated 03.01.2025. Further, CPCB was informed for site inspection. CPCB visited the unit on 15.04.2025 and submitted the inspection report *vide* email dated 16.07.2025 stating that **the unit is complying with SOP of MoEF&CC**. However, it was not clear from the inspection report whether the unit can be granted permission for import of **RONO (A1160)** or not, therefore clarification for the same was sought from CPCB. Meanwhile, the applicant *vide* email dated 23.09.2025 informed that they do not want Rono as an item for import and asked to issue the permission letter for the rest of the items.

3. Accordingly, the matter is placed before EC for deliberation.

The matter was last discussed in 149th meeting of EC and the EC found that that the unit was the subject of an NCLT proceeding and was closed since 2017. As a part of the NCLT proceeding, the unit has been taken over by another group, and they have initiated the process of reviving it. The EC was also informed that the applicant obtained the first CTO in May, 2009 in the name of M/s Met Trade India limited. However, the applicant has submitted the application in the name of M/s Metenere Limited. Further, the CTO submitted in the name of M/s Metenere Limited was obtained in May, 2025, which do not align with EC's policy that the lead recycling unit should have at least 18 months old CTO before getting any import permission. The EC after hearing the views of the applicant asked them to provide first CTO/Authorisation issued to the unit in the name of Metenere Limited and previous permission issued by the Ministry, any other details indicating continuity of existence of the unit and details about the change of ownership. Till then the matter was deferred.

Now the applicant has submitted requisite details. Accordingly, the matter is placed before EC for deliberation.

The matter was last discussed in 149th meeting of EC held on 15.09.2025 and EC noted that as per the details submitted by the applicant on NSWS portal in Form - 5, they have

imported 8,000 MT of used rubber tyre scrap against the previous permission issued vide dated 19th June, 2024. However, in the CA certificate provided by them, the imported data is shown only 522 MT (FY 2024-25). Further, EC also found that in EPR registration certificate, instead of company's name, M/s Kapil Gulati name is mentioned. Further, applicant was not present during the meeting to clarify the queries of EC. Therefore, EC recommended that applicant may provide details/clarification on the aforesaid issues for reconsideration of the case, till then the matter was deferred.

Now, the applicant has provided the requisite details/clarification in this regard. Accordingly, the matter is placed before EC.

2.14. M/s M.J. Rubber and Reclaims, Ludhiana, Punjab (F. No. 23/6/2023- HSMD)

The applicant has requested for the extension of validity period of permission granted for import of 8,341 MT of Used Rubber Tyre Scrap/tube scrap (B3140) *vide* letter dated 29th May, 2024 by at least six months. It is mentioned that they could not import the full quantity due to some reasons and have imported only 5,663.875 MT out of the 8,341MT so far. The balance quantity could not be imported due to persistent and unforeseen geopolitical instability in Europe and the Middle East, especially the recent conflict between Iran and Israel.

2.15. M/s Swarna Rubber Industries LLP, Ludhiana, Punjab (F. No. 23/82/2022- HSMD)

The applicant has requested for the extension of validity period of permission granted for import of 10,954 MT of Used Rubber Tyre Scrap/ ube scrap (B3080/B3140) *vide* letter dated 29th May, 2024 by at least six months. It is mentioned that they experienced delays using NOC due to disruptions in Eastern Europe. The conflict led to a significant increase in maritime shipping costs and a shortage of containers in the international market. As a result, ships had to be rerouted, resulting in congestion and delays in cargo flows, which further exacerbated global supply chain issues.
