**AGENDA NO. 1. IMPORT OF LEAD SCRAP/BATTERIES SCRAP**  
**(B1020/A1160)**

**1.1. Request for removal of condition i.e. "Prior Informed Consent from the Exporting Countries Required" by M/s Eswari Global Metal Industries Pvt Ltd, Karnataka, Pilot Industries, Alwar and Ardee Industries, Andhra Pradesh - reg.**

M/s Eswari Global Metal Industries Pvt Ltd, Karnataka, Pilot Industries, Alwar and Ardee Industries, Andhra Pradesh has requested to reconsider the condition for Basel no. that fall under Part 'A' of Schedule III in the Hazardous and Other Wastes (Management and Transboundary Movement) (HOWM) Rules, 2016 as amended from time to time which mandates the Prior Informed Consent (PIC) from exporting country for import of hazardous waste. However, as per the Basel convention procedures prior inform consent from the importing country is required.

It is mentioned that the purpose of Basel convention is to ensure that the hazardous waste is recycled in an environmental sound recycling facility and the importing country is aware of the import of the waste. Since, MoEFCC has given permission only to environmentally sound recycling facility and without MoEFCC permission copy people cannot import hazardous wastes. They further stated that the permission of MOEFCC for imports might be considered as a Prior Informed Consent from the importing country. Hence, it will avoid any redundancy.

*The matter was last discussed in 137<sup>th</sup> EC meeting and the committee deferred the matter for more deliberation in the next EC meeting.*

*The matter was last discussed in 137<sup>th</sup> EC meeting and the committee recommended import of only 4,798 MT (based on his actual processing of 7,918 MT) Lead Scrap (ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay, Roses, Rono, Roper, lead Grids, Lead Paste, Lead Dross, Lead scrap in crushed or powder form, Lead Acid Accumulators, Lead powders & Flakes (B 1020), Rink and Rains (A1160) with not more than 2% of liquid/electrolyte by weight in a given lot/consignment/container). Permission will be granted after submission of site visit report by CPCB stating compliance of SOP without referring the application to the EC. The import of RINK & RAINS (A1160) are allowed subject to the Prior Informed Consent (PIC) of the exporting country. Further quantity will be given after verification of actual material balance by CPCB. The EC also noted that the applicant was carrying out job work and mentioned that the job work quantity should be counted only once and may be verified by CPCB separately.*

Now CPCB has submitted the compliance report mentioning that the unit is complying with SOP. However, job work was not clearly mentioned in the report and CPCB is yet to clarify about that. Further, in the inspection report it was found that the unit was having production of 10,603 MT in FY 2023-24. However, earlier the production shown by the unit was 23,864 MT. Therefore, the matter is placed before EC for deliberation.
